## Fee Structure for Academic Year 2022-23 & 2023-24

Dear Parents.

Compliments of the Season!

The unprecedented situation caused by COVID 19 pandemic has forced us to change and adapt to newer ways of living, working, and learning. We as a school have left no stone unturned in ensuring seamless continuity of academic delivery in our school. Our teachers and staff have done an incredible job in keeping your child's learning process continued, uninterruptedly through online classes.

We are aware that many people are going through financial hardships. But let us assure you that irrespective of the personal financial condition of any parent we have not let it adversely affect the learning of any of our students. In fact, the school management on humanitarian grounds has been providing all possible help to the parents who have been unfavorably impacted by the onslaught of the pandemic situation.

Considering the unusual circumstances, the fee also was not revised last year. This despite the fact that there has been no reduction in school expenses. We have been paying salaries to all our staff on time every month. Even though there has been a minor reduction in some cost heads, the school on the other hand has to spend more on maintenance of sanitization and implementation of covid protocols in order to ensure the safety of staff and students. Additionally, school has incurred costs for creating back-end infrastructure for supporting online classes seamlessly along with usual services and contracts to support the school to deliver relevant learning experience.

We are a permanently unaided school. Being permitted as a self-financed school under the concerning legislation of the State Government of Maharashtra we rely on the fees alone for upkeep and the functioning of the school.

The school Management has proposed the following fee for AY 2022-2023 in accordance with the provisions of Section 6 Sub Section 1 B of Maharashtra Educational Institutions (Regulation of Fee) Act, 2011 & The Maharashtra Educational Institutions (Regulation of Fee) (Amendment) Act, 2018.

This sub section explains that (1B) The management of private unaided schools and permanently unaided schools who does not choose to declare the fee structure as per the provisions under sub section (1A) shall be eligible to propose the fee in the school which shall not be more than previous academic year fee plus an amount of fifteen percent of the said fee provided that, the private unaided schools may increase the fee after two years from the date, the fee approved by the Executive Committee or Divisional Fee Regulatory Committee, as the case may be

The same was informed and discussed with the Executive Committee of the Parent Teacher Association in the meeting dated 23<sup>rd</sup> October 2021.
