The Management of Amanora School has resolved to declare the standard-wise fee structure before the commencement of admissions for the academic year 2026-2027 and 2027-2028 to ensure transparency and allow parents ample time to plan for the upcoming academic terms. This declaration aligns with the provisions and procedures prescribed under:

- The Maharashtra Educational Institutions (Regulation of Fee) Act, 2011
- The Maharashtra Educational Institutions (Regulation of Fee) (Amendment) Act, 2018
- The Maharashtra Educational Institutions (Regulation of Fee) Rules, 2016

The fee structure applies to students from Nursery to Grade XII for the academic years 2026-27 and 2027-28. Please see the details below.
